### Medicare-eligible retirees

### Fall Enrollment begins Oct. 30

The Fall Enrollment period for Medicare-eligible retirees in the Texas Employees Group Benefits Program (GBP) is Oct. 30 through Nov. 17. It is the only time of the year you can enroll in coverage for yourself and/or your eligible dependents without a qualifying life event (QLE). All changes made during this period are effective Jan. 1.

### What's new for Plan Year 2024?

- Express Scripts, Inc. will be the new administrator of the HealthSelect<sup>SM</sup> Prescription Drug Program and HealthSelect<sup>SM</sup> Medicare Rx starting Jan. 1.
- EyeMed Vision Care, LLC (EyeMed) became the new administrator for the State of Texas Vision<sup>SM</sup> program Sept. 1. (See page 3 for more).
- Premiums for the HealthSelect<sup>SM</sup> Medicare Advantage Plan will increase by about 5–7%.
- Premiums for DeltaCare® USA dental health maintenance organization (DHMO) will increase slightly. They'll be back to PY22 rates, after a one-year decrease due to a COVID-19related refund from Delta Dental. You'll find more information in your Fall Enrollment packet.
- HealthSelect<sup>SM</sup> Secondary plan's total annual in-network out-of-pocket maximums will increase to align with IRS maximums.

# Why are Medicare Advantage rates increasing?

Premiums are increasing by about 5–7% due to higher medical and prescription costs. The 2024 premiums are still lower than they were in 2020, before UnitedHealthcare became the insurer of HealthSelect Medicare Advantage.

### Watch for your enrollment guide in the mail

Your Fall Enrollment packet will have helpful details about these changes, and more. ERS will send your packet in October with information about your benefits. You also can visit the Fall Enrollment page on the ERS website to view the Fall Enrollment guide, premium rates and information from plan administrators.

### Enrolling in/dropping coverage outside of Fall Enrollment

To enroll in coverage outside the Fall Enrollment period, you must have a QLE, such as marriage, divorce or loss of other coverage. Medicare-eligible retirees may drop any coverage, reduce optional life insurance coverage or change from one health plan to the other any time of year without a QLE. If you are a retiree who is not eligible for Medicare, your enrollment period ended in July, and you can only enroll in new coverage due to a QLE.

# **Express Scripts transition Jan. 1**



On Jan. 1, 2024, Express Scripts and Express Scripts Medicare (PDP) will become the new administrators for the HealthSelect<sup>SM</sup> Prescription Drug Program (PDP) and HealthSelect<sup>SM</sup> Medicare Rx, respectively. The current administrators, OptumRx (non-

Medicare) and UnitedHealthcare® (Medicare) will continue to manage the plans through Dec. 31.

#### Welcome to Stuart Greenfield, our new trustee



As you may have heard, there's a new trustee on the ERS Board. Stuart Greenfield, Ph.D., who retired from the State Comptroller's Office, was elected this spring. ### **Annuity payment dates**

ERS deposits or mails your annuity payment on the last business day of the month.

Go to the ERS website and search "Manage Your Annuity Payments" for instructions on changing your tax withholding, personal information and more.

If you are a retiree from another system, such as the Teacher Retirement System (TRS), the Texas County District Retirement System (TCDRS) or the Texas Municipal Retirement System (TMRS), contact that system for annuity payment dates.

### **Annuity Dates**

- · Sept. 29, 2023
- Oct. 31, 2023
- Nov. 30, 2023
- Dec. 29, 2023



### Possible changes in annuity amounts for non-Medicare retirees

Retirees not eligible for Medicare will see a change in their annuity checks if they made new benefit elections during Summer Enrollment. Even if you didn't make changes, you might have a different net annuity amount beginning in September, if you are enrolled in:

- the DeltaCare USA dental health maintenance organization (DHMO), because premiums increased Sept. 1, or
- Optional Term Life Insurance and moved to a new age bracket before Sept. 1, because you had an age-based premium increase.

# Current vision enrollees automatically transferred to EyeMed

EyeMed Vision Care, LLC became the new State of Texas Vision<sup>SM</sup> plan administrator on Sept. 1. If you are currently enrolled in the State of Texas Vision plan, your coverage transferred automatically to EyeMed unless you dropped coverage before Sept. 1. As a retiree, you can drop coverage at any time. You don't have to wait for Summer or Fall Enrollment.

#### **ID** Card

EyeMed sent all State of Texas Vision participants a welcome kit with two new ID cards, which you can begin using now.

### Find a provider

Search the EyeMed provider network by clicking "Find a Provider" at member.eyemedvisioncare. com/stateoftexasvision/en. If you don't see your current provider, you can complete and submit the "Nominate a provider" form on the website.

### Register for an online account

Visit the State of Texas Vision website at **stateoftexasvision.com** to register for an online account. Your online account allows you to view claims and other personal information transferred from Superior Vision. You will also find information about additional discounts and tools you can use to save money when you buy glasses or contact lenses.

#### No need to re-enroll

Because your enrollment in your ERS prescription drug program is based on your health plan, you and any eligible dependents who participate in a HealthSelect medical plan do not need to take any action during this transition.

Your account information will be securely transferred from the current administrator to Express Scripts or Express Scripts Medicare PDP, depending on your Medicare enrollment status.

### Will I get a new ID Card?

You and any enrolled dependents will receive a new ID card for your prescription drug plan as part of your welcome kit from Express Scripts or Express Scripts Medicare PDP. Please use this card for prescription drug purchases beginning Jan. 1. Continue to use your OptumRx or UnitedHealthcare prescription drug plan card through Dec. 31.

# Look out for mail from ERS with more information

If you receive mail from ERS, Express Scripts, Express Scripts Medicare PDP, OptumRx and/or UnitedHealthcare, please open and read it. It may be branded with the HealthSelect PDP or the HealthSelect Medicare Rx logos.

- If you are a Medicare-eligible retiree or dependent, you will get additional information about the Express Scripts Medicare PDP plan in your Fall Enrollment packet. ERS will also offer Fall Enrollment webinars and in-person Fall Enrollment fairs with Express Scripts Medicare PDP representatives. See your Fall Enrollment packet for registration information.
- ERS will mail Express Scripts information to non-Medicareeligible retirees and dependents in November and December.
   ERS will also offer webinars hosted by Express Scripts representatives. Check the ERS Events Calendar ers.texas.gov/Event-Calendars later this fall to register.
